COMES NOW Plaintiff ARMANDO SOTO (hereinafter "Dr. Soto") and for his Complaint respectfully represents as follows:

1. Dr. Soto is a resident of the State of Florida with a business address in Orlando, Florida.
2. Defendants John Does 1 through 10 are unknown persons, firms, entities, or corporations that have engaged in various illegal, unauthorized, and wrongful actions against Dr. Soto as hereinafter described. Defendants' identities, locations, and residences are currently unknown to Dr. Soto because Defendants, in perpetrating their illegal, unauthorized, and wrongful actions, have intentionally hidden their identities to evade detection. However, upon information and belief, some Defendants may be located within the Commonwealth of Virginia.
3. In order to perpetrate their unlawful actions against Dr. Soto, Defendants have utilized multiple Internet websites, including but not limited to "www.ratemds.com", that are widely accessible and utilized throughout the Commonwealth of Virginia.
4. Defendants have engaged in a malicious campaign of unlawfully defaming and spreading lies about Dr. Soto and his business practice and have utilized the aforementioned Internet websites to advance their campaign against him.

5. As part of their campaign, Defendants have directly and indirectly contacted Dr. Soto's patients and potential future patients to spread false and defamatory information about him and his business practice.

6. Defendants' actions have damaged Dr. Soto in his good name and reputation.

7. Defendants have conspired together, acted as an agent for each other, and joined together in this misconduct through a meeting of the minds in an agreement, understanding, and effort to carry out the acts alleged herein.

8. Defendants' conduct is negligent, reckless, intentional, malicious, wanton, and/or represents a conscious and total disregard for Dr. Soto's rights. Defendants' conduct caused, and continues to cause, Dr. Soto to be seriously damaged.

9. Defendants have utilized the Internet website "www.ratemds.com" to post false and defamatory statements regarding Dr. Soto and his business practice. Some of these statements include, but are not limited to: "I had two procedures. One was a redo breast augmentation. I had no visible scars, they were the appropriate size, but needed to be redone. My first surgeon was amazing, but retired. Dr. Soto made them much too large (against my desire) and the 9" scars are HORRIFIC. Frightening and unnecessary. My breasts are uneven and I was charged for a procedure which two other surgeons have said was not done. I am also in chronic discomfort on one side, and am saving to either have an explant or have them redone. I would have to agree that he is after the money and not a skilled nor caring surgeon. I am writing only to encourage you to get referrals from other doctors, friends etc. and weigh your options carefully." A true and correct copy of some of these false statements is attached hereto and made a part hereof as Exhibit A.

10. Defendants are working under an agenda to cause irreparable harm to Dr. Soto and his reputation.

COUNT I
DEFAMATION

11. The allegations contained in paragraphs 1 through 10 and all subsequent allegations are adopted and incorporated by reference as if set forth fully in this paragraph.

12. As described herein, Defendants have authored, published, and distributed materially false and defamatory statements about Dr. Soto.

13. Defendants knew that said statements were false or acted negligently in failing to determine the facts on which the statements were based.

14. Dr. Soto has been seriously damaged as a direct and proximate cause of this defamation by Defendants.

COUNT II
TORTIOUS INTERFERENCE WITH CONTRACT RIGHTS

15. The allegations contained in paragraphs 1 through 14 and all subsequent allegations are adopted and incorporated by reference as if set forth fully in this paragraph.

16. Defendants knew of the existence of multiple contractual relationships between Dr. Soto and his patients.

17. Defendants, through the misconduct alleged herein, intentionally and materially induced Dr. Soto's patients to end their contractual relationships with Dr. Soto.

18. Dr. Soto has been seriously damaged as a direct and proximate cause of this tortious interference with contract by Defendants.

COUNT III
TORTIOUS INTERFERENCE WITH BUSINESS EXPECTANCIES

19. The allegations contained in paragraphs 1 through 18 and all subsequent allegations are adopted and incorporated by reference as if set forth fully in this paragraph.

20. Defendants knew that Dr. Soto had a reasonable expectation of entering into valid business relationships with new patients, with the probability of future economic benefit to Dr. Soto.

21. Defendants intentionally and materially interfered with Dr. Soto's prospective business relationships by wrongfully acting as alleged herein.

22. Dr. Soto has been seriously damaged as a direct and proximate cause of this tortious interference with prospective business relationships by Defendants.

COUNT IV
CONSPIRACY TO INJURE IN TRADE, BUSINESS AND REPUTATION
UNDER VA. CODE § 18.2-499

23. The allegations contained in paragraphs 1 through 22 and all subsequent allegations are adopted and incorporated by reference as if set forth fully in this paragraph.

24. Defendants have combined, associated, agreed, mutually undertook, or concerted together, and with others not presently known to Dr. Soto, and acted as agents of each other, for the purpose of willfully and maliciously injuring Dr. Soto in his reputation, trade, business, and profession by committing the tortious acts alleged herein.

25. Defendants' defamatory actions tend to injure Dr. Soto with respect to his trade and impair confidence in his character or ability.

26. Dr. Soto has been seriously damaged as a direct and proximate cause of this conspiracy of Defendants and those with whom they are acting in concert.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff Dr. Soto moves for judgment against Defendants:

(a) Granting preliminary and permanent injunctive relief against Defendants, and their agents, servants, and employees, and against any and all persons, firms, or corporations with whom Defendants have acted in concert who receive actual notice of the order by personal service or otherwise, enjoining them from directly or indirectly engaging in any of the illegal, unauthorized, and wrongful acts complained of herein and granting such other injunctive relief which the circumstances may require in order to protect Dr. Soto's interests;

(b) An award of compensatory damages in the amount of Forty-Nine Thousand Dollars (\$49,000.00);


(c) An award of exemplary and punitive damages;

concerns and you are in and out of there so fast. Had to find a new surgeon to fix my problems and he is so caring and warm. Wished I had gone to him first. Very sad experience with my breast augmentation. Complications developed 4 weeks after surgery which possibly related to bleeding in the pocket. He never once called to see how I was doing after complication was diagnosed by him. He wanted more money to fix it and alot of money. He said that would not be an issue. He also suggested I cut down the size of my areola. I have terrible "rope-like" scars around my areola and under my breasts. As for my tummy tuck scar, it looks awful. It is not symmetrical and comes up high in the middle. I can't even wear a bikini anymore because the incision is so high and snake like. The ends of the incision line are puckered. When I complained, he said he could fix them but would need to cut several more inches around towards my hips to close them flat. He also ruined my belly button. The keloid around my belly button is bright reddish purple. He has injected it over five times with cortisone as well as lasered it. The worst of all? He has left me unsymmetrical from one side of my body to the other. He claims I was like that before. Run from him.

I visited two different surgeons and they have both confirmed it's in fact a double bubble and one of them offered to do a revision on me for a discounted price as long as he could use my story. As far as the areola, he said he couldn't make a perfect beautiful circle because then I would not have the roundness I desired. I am very disappointed with Dr. Soto for performing such a poor job and just said to go get a bleach cream. at no point prior to surgery did he ever mention the possibility of my areola's being deformed, had I known that I would have never gotten them reduced.
